# PUBLIC PORTION (5 MINUTES MAXIMUM PER SPEAKER)

Leslie Dominguez-Rodriguez, 758 Convery Boulevard: Please consider making Perth Amboy a partisan town. No one is afraid of changing the election. People should not be harassed for the way they voted in the last municipal election.

David Caba, 159 Lewis Street: We need to move forward after the election. I hope this Council moves forward. I wonder why Mr. Pabon decided not to continue being Council President even though he was the top vote getter in the election.

Ken Balut, 359 Bruck Avenue: Police officers were promoted and the promotions were done in the closet.

Council Member Pabon: There will be a ceremony for them in the future.

Ken Balut: MCIA is part of the reason we had a financial problem and why our bonding was bad. Our state/county politicians want to run this town. The County paid way too much money for the Washington Street Park.

Iris Rodriguez, 335 Fayette Street: I still have issues with parking in the Fayette Street area. We should have residential parking for the 7 pm - 7 am period. Can a police officer working off duty use a city police car? I will continue complaining about this parking situation.

Bob Sottilaro, 722 Gornik Drive: Acknowledgement should go to Ms. Goldy and Mr. Fehrenbach for making our bonding rates better. Council Members should deliberate with conscience and not politics.

Virginal Lugo, 316 State Street: Our credit rating has gotten better but we need to look at our budget and tax base. Many people are losing their homes. We have a huge unemployment rate in the City. We need to create jobs. The youth don't have jobs. We have a homelessness issue in the City.

JoAnn Jimenez, Assessor: The average taxes for a one family home are \$7,400.00.

Alan Silber, 244 Rector Street: I appreciate the way Joel Pabon ran a meeting. I hope Ms. Nanton continues running the meeting the same way. We should eliminate all the democrats/republicans. At this last election much of the money came from politicians from out of our county. We should put a push on the library completion.

Stan Sierakowski, 679 Charles Street: Our Police Chief was arrested for theft of services. The Business Administrator recommended his suspension over 6 months ago. The Mayor kept him on. The Mayor has no integrity. Three or four years ago, the Tax Assessor gave reductions to homeowners. The third section of town received less money than the other 2 sections.

Rabbi Ari Saks, 325 Rector Street: I was at the recent Police Department swearing in and there will be a ceremonial swearing in in the future. How do you define unity?

Council President Nanton: We'll work on a response for you rabbi.

Bernadette Falcon-Lopez, 654 Jacques Street: I work on the food coalition. There are feedings throughout the City, throughout the year.

Gregory Pabon, 437 Ashley Street: Everyone should speak their mind. Council Members should vote their conscience. Do not feel intimidated.

Wilfredo Soto, 202 Hidden Village Drive: I thank all city employees for the work they do. Many of the banks caused problems for the homeowner when they refinanced and caused the foreclosures of many homes in the City.

Mayor Wilda Diaz: I congratulate Lisa Nanton as the new Council President and also Joel Pabon as the previous president. All residential properties in the City of Perth Amboy were adjusted. I thank all the agencies that help our homeless. I inform the Council of all decisions. I respect all city employees, they are my co-workers. We will have a police appointment promotion ceremony in the future. There should be no apologies for people who support candidates.

Lisa Ferreira, 394 Bruck Avenue: I thank you for the sign being put up on my street. The politicians that come into this town should not take sides. They should treat everyone equally. I welcome the politicians coming into this town. We need to see some of the parks rehabilitated.

### **COUNCIL COMMENTS**

Council Member Pabon: There were no deals made for the Council Presidency. I believe in equal opportunity for the Council Presidency. I believe Lisa Nanton will do a great job as President. I agree we need to see completion of some of the parks.

Council Member Gonzalez: The Rt. 35 bridge really needs to be followed up on. This will be a priority for me.

Council President Nanton: I thank the Council for its support in electing me as President. This Council has worked as a team. We decided we would rotate the Presidency.
