Regular Meeting of the Council of the City of Perth Amboy was held on Wednesday, June 10, 2015 in the Council Chambers, City Hall, Perth Amboy, New Jersey at 7:00 p.m.

Stan Sierakowski, Charles Street: Dorothy fails to mention there was an appraisal made for the Board of Education and the Housing Authority. There are negotiations. This is electioneering for November. She left out the facts.

Ken Balut, 359 Bruck Avenue: There is less and less on the agendas. It doesn't have the names of the bond counsel. You could be voting on someone who donated to your campaign. It's supposed to be open and transparent. Wasn't McManimon the democratic committee lawyer? Wasn't he the lawyer for the lawsuit? Can I have the names of the bond counsel?

Mark J. Blunda: With regard to R-288, I don't believe when we had multiple professional appointments in response to RFP's we listed the names on the agenda, rather they've been listed in the Resolution itself. There are 3 approved bond counsel, McManimon and Scotland; Parker McCay and Kraft & Capizzi. As to the issue of a conflict, I researched it with regard to Mr. Petrick, Mr. Pabon and Fernando Gonzalez. In my estimation, none of the three had a direct financial interest with the appointment of McManimon, of which Mr. Northgrave is a partner and would not benefit financially from them being bond counsel. The question is whether there is an indirect personal interest as you pointed out Mr. Northgrave challenged certain vote by mail ballots. He did this on behalf of a slate that included Mr. Petrick and Mr. Pabon that would raise the appearance of impartiality. On the other side, Mr. Gonzalez was directly adverse to Mr. Northgrave in the Superior Court lawsuit. All these would give the appearance of being tainted. However, we'd be left with not having a quorum. Under the Doctrine of Necessity it would be my opinion all three could vote on it With regard to your other issue, I agree, with certain resolutions, if there were more detail listed on the agenda, it would make it easier for people. I'll look into it. As for the Housing Authority matter, we are reaching out to the Board of Education and the Housing Authority to see if they could come to a meeting to talk about a 3rd party.

PUBLIC PORTION (5 MINUTES MAXIMUM PER SPEAKER)

Elizabeth Gonzalez, 315 Market Street: I got a ticket for parking on Walnut Street. There is no yellow curb. There are 2 signs. It says no parking between signs. I was wrong. Riverdale has 18 wheelers going down Walnut Street that come close to my houses. Why can't they move their fence? Why isn't the whole curb yellow?

Council President Nanton: You would like us to look into having the trucking company move there fence closer to their building?

Elizabeth Gonzalez: Yes.

Resident of 479 Miller Street (Not able to get her name): The drivers in the City are rude to pedestrians. My husband and I walk, we don't have a car. It's very bad at the corner of Fayette and State Streets. Do we have a camera on the lights? Also, we have had our garbage cans stolen. We can't keep replacing them.

Ken Balut, 359 Bruck Avenue: I'm still waiting for the residential parking report on Bruck Avenue. There is illegal housing, that's why there is no parking. I'm still waiting for how much the Y cost us a year. I've seen kids running around the Rosengarten property. They closed on that property in July of 2014 and there is still no fence. I don't see graffiti getting cleaned up. Where is the leeching coming from? I'd like to know about the study and the fence.

Jillian Barrrick: Our traffic division did do a study of Bruck Avenue and the residential parking. The report said there are several properties that have driveways and there is ample overnight parking on the street and no changes to the ordinance are necessary. As to the leeching, there was an environmental study done that we have, you are welcome to read it. As far as the fence, I walked this property with the Chiefs of the Fire and Police Departments and members of the County Parks Division and discussed the plan for the property. The fence is on the next County Agenda for procurement.

Ken Balut: I'd like a copy of the parking study.

Stan Sierakowski, Charles Street: If there's an appearance of a conflict, couldn't the Middlesex County Ethics Board look into it? There are 2 other bond counsels. This is a miss application of the Doctrine of Necessity.

Mark Blunda: I determined there is an appearance of conflict, that's why it was't necessary to have someone else make that determination. I relied on two prior cases, Alan vs. Toms River Board of Education and Gunter vs. Planning Board of Bayhead that the Doctrine of Necessity could apply due to the City Council is denied a quorum.

Susan Batista, 1074 Truxton Drive: According to the Sunshine Law, you are to disclose a potential litigation. I have a lawsuit with the City and I have yet to see it disclosed to the public or that you hired an outside law firm.

Mark Blunda: I'm aware of the lawsuit. I'm not aware of any law that says it must be announced.

Resident of 812 Holly Drive (could not understand her name): Thank you to the Director of Public Works. I had another rock thrown through my window. Has a letter been sent to Conrail, if so I would like a copy.

Jillian Barrick: I was able to reach the appropriate person at Conrail's Real Estate Division in Philadelphia. They will increase the postings of no trespassing sings, they will be addressing the debris. They won't raise the fence due to safety issues. They are forwarding the vandalism to the rail police.

David Caba, Westside Avenue: Mr. Blunda you have a lot of integrity. I might criticize you and ask the tough questions, that's my job.

Alan Silber, 244 Rector Street: Somebody should bring up that we should not accept contributions from any city employee.

Mark Blunda: With regard to the 2 resolutions dealing with the water issue, I don't know how they were allowed to reach those amounts. Both companies were in bankrupt proceedings for some time. It wasn't until recently that the bankruptcy was approved and the debts discharged. In 2008 the Mayor wanted to stop the4 financial bleeding, stoop intimidation of business owners and establish pay to pay control. I think there is progress.

George Ramos, 275 Maple Street: I was here complaining about noise and quality of life. Pay Rite Liquors at 223 Smith Street has a D.J., it's on Sundays and starts around 4:00 pm.

Jillian Barrick: I know there has been recent enforcement activities by the police department and code enforcement.

Larry Cattano: This was brought up by at our Director's Meeting. I understand the mattresses are gone.

George Ramos: No they are still there. I complain nothing is done.

Larry Cattano: Last year's issues were different, it was code enforcement issues. An officer has been hired by that establishment.

Jesus Nunez, employee of Pay Rite Liquors (translated by Council Member Irizarry): What is happening is personal. This is racist. We don't have a problem. Only 1 person complains. We have a police officer there to avoid these problems.

Lisa Ramos, 275 Maple Street: I don't believe it's just us. Religion is not the issue. My house vibrates. It's not personal. They are not the owners.

Angel Rivera, 440 Thomas Street: Due to the smell I can't use my backyard. We have a letter signed by the residents that we gave to the Mayor and Irving Lozado. Nothing was done. We've been trying a year.

Council President Nanton to Council Member Gonzalez: You were here?

Council Member Gonzalez: I was there and I had to leave the smell was so bad. These people want to be able to live in their home. It needs to be cleaned. The City and the County need to make sure this is properly cleaned.

Council Member Pabon: I was involved back in July and August. Code Enforcement was involved. I don't think we are going back often enough. Once is not enough. Code Enforcement needs to go more.

Jillian Barrick: We will have the Health Department involved.

Maria Sanchez (translated by Council Member Irizarry): I want to complain about as police officer. He gave me a ticket because I didn't come to a full stop. I didn't commit any infraction. How long do you have to stop? He followed me for 6 blocks then stopped me and gave me a ticket. He was arrogant and abusive. I'd like this investigated.

Larry Cattano: The statute says complete stop. She must go through the court process. Following for 6 blocks is standard procedure. As far as the demeanor of the officer, we will set up a meeting to address this.

COUNCIL COMMENTS

Council Member Irizarry: If I look at people and don't speak, I'm criticized. If I do speak, my words are twisted. I did go the bar and take pictures. It had nothing to do with religion or race. It's not personal.

Council Member Pabon: I was there and I took pictures too. Maybe we need code enforcement there to explain. Maybe there needs to be a clarification of the noise level and the times. Also, I've had complaints about loitering around the train ticket machine

Council Member Gonzalez: You have ruled that all three of us were in conflict. Can I make a complaint to the Middlesex County Ethics Board?

Mark Blunda: Are you asking if the law firm had a responsibility to remove themselves?

Council Member Gonzalez: They have a responsibility.

Mark Blunda: If the Council wishes to, I will send a letter. The research showed an appearance of a conflict. Due to case law, the Doctrine of Necessity you are relieved.

Council Member Gonzalez: I would like you to. They have an ethical responsibility to remove themselves.

Council Member Pabon: If you feel that way, maybe you should just do that.

Council Member Gonzalez: I'd like to give them the benefit of doubt. We have an opinion b an attorney.

Council Member Pabon: Just send it.

Mark Blunda: I will send it.

Council President Nanton made an announcement regarding the museums and July 2^{nd} Fireworks Festivities.

ADJOURNMENT

There being no further business to come before the Council, motion was made by Council Member Petrick, seconded by Council Member Pabon to adjourn the meeting 9:32 p.m. and was carried by the following vote: Yea Council Members Gonzalez, Irizarry, Pabon, Petrick and Nanton. Nay—none.
