HEARING OF CITIZENS (10 MINUTE MAXIMUM)

Reinaldo Aviles, City Resident – Lack of a civil tone and working relationship between the Council and some members of the public.

Reinaldo Aviles, 16 Harbor Terr. - provided a history of the term "gadfly". He advised that there are 3 types of gadflys and that many good ideas come from the gadflys. He indicated that the Council does not take all good ideas seriously and that many times nothing comes of the proposed ideas. He indicated that people should be encouraged to attend meetings and express their ideas.

Council Member Gonzalez: This Council followed through this week on an idea from a resident with regard to the Trap, Neuter and Release program.

Council President Nanton: Many suggestions from the public have been considered. However, just because one person brings forth an idea, doesn't mean that the Council is required to take action. Many times I have asked for additional info to help stimulate discussion among the Council, but I don't receive the info.

Public Portion (5 Minutes Maximum Per Speaker)

Stan Sierakowski, 679 Charles St.: The amount that was owed in back taxes to the City, for the property that was recently donated to the County, is approximately \$883,000. The taxes were not paid for about 6 years. The foreclosure didn't occur until late last year. You should find out who the individual owners of the property were. The taxes due to the City should have been approximately \$3m.

David Caba, 139 Lewis St.: An employee of the City made a racial remark at a December 2014 Council Meeting. The Mayor stated at Monday's Caucus Meeting that she defends all city employees. Does that mean she still defends the suspended police chief? The Mayor needs to take a stand and do something about that employee. That should not be tolerated.

Alan Silber, 244 Rector St.: Only people that love and will vote for the Mayor should apply for board memberships when there are vacancies. Only they will get appointed. The others don't have any chance. If an attorney contributes to the Mayor, can the attorney be hired by the City to do work?

Mark Blunda: According to the pay-to-play ordinance, they can donate up to \$300. There's a certification that is required to be signed by the vendor.

Alan Silber: Mr. Nolan donated \$1200 to the Mayor and we just hired him for \$40,000. Can this be looked into?

Mark Blunda: I will look into this and report back at the next meeting.

Ken Balut, 359 Bruck Ave.: Mr. Nolan is huge in the Democratic Party in Middlesex County. The City Clerk should ask for the anti-corruption ordinances from Ewing and from Princeton Twp. I would like to speak to someone about getting a personal parking space in front of my home. There is a large trailer on Leon Ave. with people living in it. Nobody is doing anything about this. Doesn't Code Enforcement see this?

Mark Blunda: Any code violations should be submitted to the BA or to Code Enforcement.

Reinaldo Aviles, 16 Harbor Terr.: In the past, I spoke about instant runoff voting. I provided all types of documents. Nothing was done. I went to Court in New Brunswick twice last week to see what was going on with regard to the voting by mail issue. The Judge indicated there was a lot of voter tampering in the last municipal election.

Diane Signorile, Staten Island, NY: I am here to help you with the Trap, Neuter, Release (TNR) program in Perth Amboy. I am TNR certified.

Council President Nanton: The City supports TNR.

Virginia Morales, 745 Barry Ave. - Provided the definition of feral cats, and explained the TNR program and the TNR training process. She advised that the animal shelter needs to keep logs. She indicated that the City needs to prepare signs for the members of the community for the feeding of the feral cats. She indicated that the shelter has improved tremendously over the past few years, and asked that the Council support the TNR initiative.

Dave Szilagyi, 42 Market St.: Discussed decorum at council meetings. In the past, 5 minutes were allowed for each item on the agenda. You can always change the rules of decorum if you want to do so.

COUNCIL COMMENTS

Council Member Gonzalez: The trucks that are driving on High St., to do work at the waterfront, are bringing a lot of mud all through High St. The companies should be required to clean up after themselves. Someone needs to address this.

Jillian Barrick: Part of the contract is that they need to sweep the streets. I will call the company.

Council Member Gonzalez: I have asked Mr. Blunda to review the payto-play ordinances on two issues and was wondering if he has a response for me.

Mark Blunda: I am still reviewing the matters.

Council Member Gonzalez: I am paying approximately \$14,000 in taxes for my home. I don't think a big enough effort is being made to put ratables on the books. Our waterfront has not been developed like it should have been. I am concerned about the old Police Dept. and the old First Aid Squad buildings that are sitting there and not bringing in any taxes. The Washington Street Park and the So. Second Street Park are not being built by the City, but we will be carrying them. We need to bring ratables into this town.

Council Member Irizarry: Have we completed the review on the Chaplain Ordinance?

Jillian Barrick: There have been meetings to finalize and revamp the entire process. We will provide you with the results after they have been finalized.

Council Member Pabon: Can we get a time frame for the start of the TNR program? Grants will be funding the trial TNR program. We are 12-13 parks behind in the City. The waterfront beach is being used by many families. I am very glad that So. Second Street is going to become a park. I am all for parks. We need them. We are heading in the right direction.

Council Member Petrick: We need both parks and ratables. Parks are invaluable to us. High density housing needs parks. We need to move on the old city properties. The Council should send a letter to Kinder Morgan and congratulating them on their new acquisition.

Council Member Petrick to Mark Blunda: We should get the Ewing and Princeton Twp. anti-corruption ordinances.

Council President Nanton: There is a lot of litter in the streets after the snowfalls. Homeowners should clean up in front of their homes. Compiling all the elections into one election is a result of many people complaining about all the elections that were held here in the past. We have a big debt. We need ratables. We need to respect each other.

Council Member Gonzalez to Frank Dann, Dir. DPW: Why was the snow removed curb to curb on Smith St., but not the snow on the sidewalks?

Frank Dann, Dir. DPW: We ran out of time to get rid of it.

Council Member Pabon: We should see if the BID can remove the snow off the sidewalks with some small bobcats.

Jillian Barrick: We can provide an analysis for next year.

ADJOURNMENT
