PUBLIC PORTION (5 MINUTES MAXIMUM PER SPEAKER)

Maritza Criado, 812 Holly Drive: The Council is the link between the public and the government. I provided my sons name for the war memorial and his name did not appear on the memorial this past Memorial Day. I still did not receive an answer regarding the issue of the rocks that are being thrown at my house. I have been advised that my development is private property. We still have an issue with the size of our water meter.

Council Member Pabon: This was addressed before. It is private property. The Police Dept. will be addressing the rock issue.

Jillian Barrick: There was a request that the City put a fence up around her house but it's Conrail property. We can't put a fence on their property. We will continue to work with Conrail.

Maritza Criado: We don't receive the support of the Police Dept. when we call to report an issue.

Council President Nanton to Jillian Barrick, BA: Please send a letter to Conrail to address the issue. Continue sending letters until we get an answer.

David Caba, 559 West Side Ave.: Fernando Gonzalez will be the voice of the people. Perth Amboy has a large population of Dominicans. I believe that we need to pick the best candidate to represent all the people in this City.

Council Member Irizarry to David Caba: At the last meeting you called all council members liars. Why?

David Caba: It had to do with the election between Fernando Gonzalez and Sergio Diaz. You are all in cahoots with those people.

Virginia Lugo, 316 State St.: Every council member said that Fernando Gonzalez knew about the fraud. The video is there to prove otherwise. The judge stated there was no culpability on Mr. Gonzalez's part.

Arthur Brewton, 442 Convery Blvd.: There is still drug activity going on at the Remington Hotel. The Police Dept. is doing a fantastic job. However if the Police Dept. needs help, they should call in other agencies and use other techniques.

William Langford, 437 Broadhead PI.: Public buses stop in the middle of the street and they don't want anyone to pass them, especially at Convery Blvd. and Smith St. They should be issued tickets. Are we going to put benches on Smith St. so senior citizens can have a place to sit down and rest?

Alan Silber, 244 Rector St.: "Vote by Mail" was voted on by Mayor Diaz, legislative supporters and contributors. In 2009, Mayor Wilda Diaz made promises to end influence in money in politics and her administration would have zero tolerance for corruption.

Nelvi Caba, 84 Washington St.: There is still an issue with ticketing by the Police Dept. regarding commercial license plates. Sgt. Andy Montalvo gave my driver a ticket for one of my buses. He claimed it was a school vehicle. I have over 115 vehicles and this is the first ticket I received this year.

Reinaldo Aviles, 16 Harbor Terr.: I was at the court hearings regarding the election of Fernando Gonzalez. The judge indicated there was no indication of wrongdoing by either Mr. Gonzalez or Mr. Diaz. There was fraud, but she couldn't determine who was responsible. Ben Ruiz has not been convicted. The Mayor cannot be responsible for what Chief Ruiz did. The Mayor suspended him without pay. She should be commended. The election is over and we should go back to move the city forward. Fernando needs to ask his people to stop coming to the meetings and rehashing everything.

Luisa Ramos, 275 Maple St.: I live by the train station and I came to the Council last year about the noise from the bar near the train station. It stopped for a while but it is starting again. They do not respect city ordinances and authority. There are a lot of homeless people near the train station.

Edna Dorothy Carty Daniel, 277 Water St.: We had a wonderful arts festival this past Saturday at the waterfront. Everyone that attended the event was happy. Kudos to whoever organized the arts festival. Let's do it again as soon as possible. The gum is being removed on Smith St. and it looks great.

Vincent Mackiel, 215 Sheridan St.: The Governor has proposed an Exxon settlement. The City should comment on this to the DEP. Exxon shouldn't get away with this.

Council Member Pabon: I congratulate Fernando Gonzalez on his victory. There are several different types of art and the arts festival showed off a lot of different types. I thank the departments of DPW and Recreation for the work that is being done on our city parks. Code Enforcement did a good job yesterday on a case.

Council Member Petrick: We should waive the dockage fees for the "Clearwater" if it comes in this year. We need parks in our community. The parks are being used by our kids. The arts festival was a beautiful thing. We need to do more of those events. Congrats to Fernando!

Council Member Gonzalez: I voted "no" on the water increase because it affects our citizens. The election is over. I would like to encourage people to report questionable behavior. People are looking the other way. Be a good citizen and come forth. This city has a great future. We need to work together to build a better city. The arts festival was a great activity. There's a mural that will be going up on Herbert and Smith St. We need to work on making the entrance to the city better. We need to reach out to the Housing Authority to improve that area. PARTNER just received a \$500,000 grant and we should work with them to see if we can partner with them for some of the money.

Council President Nanton: I thank everyone on the arts council for all the work on the arts festival. The art was great. The musicians were also fantastic. We had people from many different communities. June 7 will be the reenactment of the arresting of William Franklin. Everyone is invited. There is a community meeting on June 1 at the Jankowski Center. Please show interest the community and attend.
