Susie Dyer, Planned Parenthood: There is no fetal donation program in NJ. We had 3800 visits in the Perth Amboy facility last year. We are opposed to any closing resolution.

Ken Balut, 359 Bruck Ave.: I investigated both Mr. Blunda and Mr. Fehrenbach before they were hired. I am concerned about the law firm that the new lawyer works for. It is a questionable firm. They got caught for overbilling. The new attorney should tell us what cases she handled in court.

Joseph Vas, 312 High St.: There's a level of frustration. I am not questioning the credentials of Ms. Perez. There was not a proper process that took place in the hiring of the attorney. I can submit my resume if you are still hiring.

Virginia Lugo, 316 State St.: The Mayor does not have a law degree. She has been here since 2008. What has she done? Ms. Perez is a political attorney that will help get funds for the Mayor's campaign.

Billy DelGado, Democratic Chair: This year our annual picnic will be held on Sunday. We invite everyone to attend.

David Caba, 559 Westside Ave.: We have an opening for the BA position. You should reach out and try to get a Dominican to fill the position.

Acting Council President Pabon: Give me the name of a Dominican that lives in Perth Amboy that is qualified for the BA's position and I will consider the name.

David Caba: We need to be part of the process.

Arthur Brewton, 442 Convery Blvd.: I want to commend the Police Dept. for the recent arrests in the murders that took place on Smith St. There are many drug activities going on at the Remington Hotel. The owner is not complying with the city ordinances. This type of business (rooming house) should not be allowed near a school.

Nelvi Caba, 84 Washington St.: I have had more than \$2000 worth of damage at the Parking Deck on my vehicles. I pay rent at the Parking Deck. I cannot park outside on the street. Nothing is being done. This has happened to my vehicles in the past.

Jeannette Rios, Parking Authority: Mr. Caba has notified me in the past of the damage and I contacted the Police Dept. The problem is that the keys are being left in the vehicles. Mr. Caba is looking for the top level to be completely fenced in. We need to get price quotes on the fencing.

Jillian Barrick: He will need to rent the spaces that we fence in.

Acting Council President Pabon: We should have a camera installed for the third floor.

Jillian Barrick: We will explore the different options.

Larry Cattano, Acting Deputy Police Chief: There have been 9 instances of criminal mischief against vehicles this past year. Many vehicles were not secured in the past. They are now being secured.

Jose Minaya, 676 State St.: I own the Triangle Café. In the past, the City would pick up my bottles. I received a letter that the City would not collect the bottles anymore. When was a resolution passed to change this? Latin people don't get help with the bottles. They only increase the cost for the taverns.

Maria Vera, 81 Madison Ave.: My neighbors and I are here to express our problems with the Dominican Festival. Rudyk Park should be the location for future festivals. We thank Chief Larry Cattano for his help. People are urinating in the neighborhoods during the festival. The festival is too big for our area. Please consider Rudyk Park for next year.

Manny Segura, Trenton, NJ: A leader should build a consensus with the residents. Dominicans in Perth Amboy only work in the trades. They do not hold positions of policy. There should be due process when a position of importance needs to be filled. No one should be in an elected position for more than two (2) terms.

Ramon Feliciano, 62 Madison Ave.: I love the Dominican Festival. However, it has gotten too large for our neighborhood. It should be moved to another area where there are no residents around.

Eleni Glykis, 555 Compton Ave.: The Library renovations are beautiful but it is not enough. Libraries today are much more than just books. I hope that the Council sees the importance of a library.

Alan Silber, 244 Rector St.: In 2009, the Mayor stated that she "vowed not to run for more than 2 terms". Councilman Fernando Gonzalez is more concerned about the smell on Amboy Ave. than of the smell that came out of City Hall at the last meeting with regard to the hiring of the Law Director. What was the rush? Did the lawyers from DeCotiis attend the last Closed Session?

Dorothy Carty-Daniel, 277 Water St.: Three (3) churches are closing in Perth Amboy. It's a problem that we can't sustain our churches. I thank you for changing the parking on High St. from angle to parallel parking. I thank Maria Vera for talking about the festival. You should not allow drinking at the festivals. It is meant to be a family event, not a drinking place for adults.

Frank Hoffman, Dept. of Public Works: Two years ago we switched over to single stream collection. There is a large volume of glass generated by taverns. We were only looking for help and cooperation. We will schedule a meeting to resolve the problem.

Orlando Leon, 51 Madison Ave.: The adults are still playing baseball in the area near my property. We are tired of calling the Police Dept. We need to have signs installed. The festival is too big for the area. There were people drinking near my house. We need respect. The festival needs to be moved. There is a noise ordinance, but after 12 midnight the carousel people were making noise and keeping the neighborhood awake.

Jillian Barrick: The signs will be installed shortly.

Christian Tallaj, 441 Thomas St.: I am here to complain about the smell coming out of the chicken place on Amboy Ave. There were many promises made by the owner of the property and his attorney. Nothing has been done. Please do something about this.

Jamie Rios, Code Enforcement.: We met with the owner and the attorney. They were going to exterminate and the doors were to be kept closed. A permit was granted today to get an exterior freezer box. He has not exterminated the property.

Acting Council President Pabon: We should do whatever we need to do to make sure this is taken care of, especially the smell. If we need to close them down, so be it. What is our plan?

Jamie Rios, Code Enforcement: There is an issue and I will be meeting with the owner tomorrow.

Jillian Barrick: The Health Dept. is involved with this.

Sylvia Santos, 962 Amboy Ave.: I have been dealing with this problem for several years. There are a lot of health issues there. I spoke to Assemblyman John Wisniewski and sent a letter to Mayor Wilda Diaz. Nothing that was promised has been taken care of. The doors are always open. There are dead chickens on the road. There are water bugs in our homes.

Council Member Gonzalez: The owner filed a police report against me for harassment because I was going there every day to see if anything was being done.

Council Member Irizarry: We need to go to the next level. We should take whatever legal action we can to correct this problem.

Jillian Barrick: The Health Dept. can shut them down.

Gregory Pabon, 437 Ashley St.: The smell is very bad in the location. It seems that the owners don't want to do anything about this problem. They let their chickens run around in the backyard.

Judy Verrone, Esq., DeCotiis FitzPatrick & Cole LLP: I am a member of the DeCotiis, FitzPatrick, Cole law firm. We are a preeminent municipal law firm that operates throughout the State. The field is always full of trash. People walk their dogs and don't pick up after them. Where is our quality of life?

Acting Council President Pabon: I feel for you. There are many garbage cans out there, but people don't use the trash cans.

Stan Sierakowski, 679 Charles St.: With regard to Comm. #13, how long is the appointment for and how often can it be renewed?

Arlene Quinones Perez, Esq.: 90 days and no reappointment is allowed.

Stan Sierakowski, 679 Charles St.: This is not a race issue. This is a money issue for the Mayor's re-election.

Mr. Diaz, 293 Smith St.: I get tickets every single day with regard to my business on Smith St. I don't have a loading zone in front of my business. It is across the street. I have put up flags on my business but Code Enforcement won't allow me to fly the flags. The flags don't bother anyone. Why am I being bothered? We no longer have sidewalk sales. Why?

Jillian Barrick: Mr. Diaz, please meet with Jamie Rios of Code Enforcement before you leave this evening.

Thomas Wright, Smith St.: The flags only promote the business. In the past, we would get a warning. Now we get tickets without warnings. We need an opportunity to make a living.

Pedro Perez, 733 Franklin Dr.: What is the status of the negotiations between the Housing Authority and the Bd. of Education.?

Acting Council President Pabon: I don't know the status. The price is still being negotiated. You should go to the Bd. of Education meeting and get a status report from them.

Pedro Perez: Maybe the State should take over the Bd. of Education.

Acting Council President Pabon: City employees should be educated in the way they deal with the public.

Jillian Barrick: We will have customer training starting next week for all city employees.

Mayor Wilda Diaz: I welcome Arlene Quinones Perez to the City. There are many issues in the City and they have to be addressed. There is much redevelopment going on in the city. We are constantly meeting with developers. The public doesn't realize how hard we work. There are areas that need improvement but we need to look at the big picture. We have stabilized taxes. I have worked hard to get the best services for our community.

Acting Council President Pabon: We need to advertise the good things that we are doing. We need to sell ourselves more.

# **COUNCIL COMMENTS**

Council Member Gonzalez: The waterfront is the pride of Perth Amboy. The streets need to be repaved. The two tones are awful. Who is going to handle the dog poop problem? The truck traffic on Amboy Ave. is terrible. I would like an update on the connector road.

Jillian Barrick: We need to acquire one last easement from the Board of Education.

Council Member Gonzalez: There are situations where children are being forced to walk on the street instead of the sidewalk (Madison Ave.--between Gordon St. and Paterson St. & Jacques St.). The train station looks ugly with all the busses that are parking in the parking lot.
