Jillian Barrick: A new position was created in the BA's office and the individual will work along the BID as support. The employee will be under my supervision.

Council Member Irizarry: We are trying to transition the BID budget to make it January to December. The Council also expends funds before the budget is adopted, correct?

Jillian Barrick: Yes, that is how the city operates until a budget is adopted. The Council, by statute, has to ratify the BID budget.

# Public Portion (5 Minutes Maximum Per Speaker)

Stan Sierakowski, 679 Charles St.: With regard to R-447, who was the director of PARA when this occurred and who is the director now? What was the money used for? With regard to R-449, what is the starting salary of a police officer?

Jillian Barrick: \$33,500.00.

Ken Balut, 359 Bruck Ave.: Was Tim Simon hurt on a fire scene due to illegal housing? Sgt. Pellot drove the Mayor to NY and got time off the next day. The OPRA response indicates that he did not get any o/t. I put an OPRA asking about 2 locations that had lines painted in front of the homes. How did that happen? There was no work order. Why is the police dept. allowed to get away with misrepresentation on OPRA's? There was a funeral recently with 3 police officers on motorcycles. Why were there so many? There is something wrong here.

Virginia Lugo, 316 State St.: A depressed downtown leads to a depressed city. This BID budget is a charade. This is the first time the budget is advertised but the ad was miniscule. Why does the BID pay \$89,000 for a BID employee?

Ana Mascenik, 710 Franklin Dr.: People in the area of the Delaney Homes are concerned about the possible placement of a new high school. It's already a congested area. You should consider a central area for the high school.

William Langford, 437 Broadhead PI.: Garbage trucks can go down my street the wrong way, but why can't a snow plow go down the opposite way. People are leaving trash cans in the street on my block to save parking spaces.

Linda Ferreira, 394 Bruck Ave.: Who was hired for the BID and at what was the salary?

Jillian Barrick: It is an entry level clerk position.

Mark Blunda, Esq.: The particular information can be obtained if you file an OPRA request.

Linda Ferreira: The quality of life in the city has gone down. It is filthy and disgusting. The Council is not working for the people. The democratic headquarters that was recently opened for the council candidates is not the true democratic headquarters.

Arthur Brewton, 442 Convery Blvd.: I would like to see auxiliary police officers in the downtown area. There is a hotel across from the Richardson school that is a problem. There was recently a shooting on Watson Ave. We need to see more police presence on the streets.

David Caba, 139 Lewis St.: There were 6 shootings in the city recently. Why were there no press releases about that?

Mirta Carde, 108 Rector St.: My daughter was employed by the city as a 911 dispatcher and moved out of town. She came back into town and she thought she would get rehired by the city. I spoke with the Mayor and we are still waiting for a reply from the Mayor, even though she promised to get back to me.

Alan Silber, 244 Rector St.: Wouldn't you like to know about shootings in town? You need to vote from your heart.

Daniel Gonzalez, 178 Long Ferry Rd.: Daethyn Nelson, who recently passed away, was a great person. I would like to commend Juan Rivera who raised \$14,000 to bring his body back to Perth Amboy from Florida. I commend Perth Amboy for sticking together when needed. There are a lot of wonderful people in the City.

Fernando Gonzalez, 129 High St.: There's a sewer on Catherine St. that smells and has mosquitos. You should look at it. Something should be done about it.

Council Member Petrick: I was not aware of this condition.

Council President Pabon: We'll get someone out there to address that.

## COUNCIL COMMENTS

Council Member Irizarry to Jillian Barrick, BA: What is the status of Mary Street and what about the ballplaying near the waterfront?

Jillian Barrick: We hope to discuss this at the next meeting. We met with residents of the area of Mary St. We will have a solution.

Council Member Gonzalez: What about Amboy Ave.?

Jillian Barrick: We met with people in the area and we found alternative parking locations for the teachers of the charter school. We'll see how that works out.

Council President Pabon: I go throughout the city regularly. There are neighborhoods and many businesses that take care of their properties and some that don't. The downtown is clean in the morning but by the afternoon it's dirty. People should take some responsibility.

Council Member Gonzalez: All councilmembers go to different parts of the city. Some people in this town are inconsiderate. We ask residents to have pride and clean up their own properties. Our noise issues are getting worse. It's time for enforcement of the noise ordinance.

Council Member Gonzalez to Police Chief Ben Ruiz: How many auxiliary police officers do we have and what are they used for?

Ben Ruiz: We have 25 auxiliary officers and they are all volunteers. They are dedicated, but they all have full time jobs. We use them for city events. We currently have 5 people in the academy. There has been a mass exodus of police officers throughout the State. We have three Alternate 1 officers that deal with quality of life issues. We have four Alternate II officers that are retired police officers. There's a process and we are working on it and building up our staffing.

Council President Pabon: Have we received anything from the AG's office on the shooting yet?

Ben Ruiz: No.

Council Member Irizarry: Is crime up?

Ben Ruiz: The stats change weekly and monthly. Serious crime puts us in a better place than where we were in the past, even with a lower number of officers per shift. I can't discuss the shootings because they are active investigations. The officers are entitled to vacation/sick time and they must attend court. We need to prioritize the calls and therefore it's hard to put people out in walking beats. Special 1 Officers can only work 20 hours per week.

Council Member Nanton: It was a pleasure to listen to the applicants for the Arts Council on Monday and I'm looking forward to the next batch of applicants at the next Caucus.
