Regular Meeting of the Council of the City of Perth Amboy was held on Wednesday, December 10, 2014 in the Council Chambers, City Hall, Perth Amboy, New Jersey at 7:00 p.m.

Kathleen Manning-DePow, 304 High St.: The Chair of the Housing Authority has been on the board for over 30 years. She refers to the executive director as her son. This is a cozy relationship. There is a clear lack of ethics. There is a lack of transparency. The director is the person that should be meeting with HUD, not the chairperson. This person is on Section 8 and lives with one additional person in a big house. I've often wondered about that. The laws are being skirted. Things have gone terribly wrong there. Prevent corruption from happening on that board. Look into your soul and do the right thing.

Ken Balut, 359 Bruck Ave.: Shouldn't a code enforcement official attend Planning Board meetings? No one is attending. The City Attorney should be handling negotiations with the YMCA, not the Councilmembers. We should get the proper amount of money due us from the YMCA. Our lawyer should not have to do OPRAS. Citizens should not have to subsidize the YMCA's pool.

Alan Silber, 244 Rector St.: A couple people got stabbed on Smith St. today. This happened when school was let out. Why don't we have community policing anymore? There was a June email regarding the appointment of Ken Gonzalez as a municipal judge. In April, Mr. Sierakowski, questioned the appointment of Mr. Gonzalez as judge. Mr. Gonzalez indicated at that time that he was not approached. The fitness trail was not ready to be opened before the November election. The trail is in poor condition.

Donald Jamal, 427 Summit Ave.: Does Nancy Martin have a current tax collector's license?

Mark Blunda: Yes, it is up to date.

David Caba, 139 Lewis St.: What is going on with the AG's investigation of the shooting that occurred last year? I would like Mr. Blunda to follow up on this matter.

Stan Sierakowski, 679 Charles St.: There were tax reductions given to city residents (including councilmembers) years ago. There were less monies given to the poorer people in town.

Diane Signorile, Staten Island, NY, read a letter, on behalf of her friend, regarding a dog that was adopted from the Helmetta Animal Shelter.

Catherine Soto, 81 Center St.: As of when are Nancy Martin's license up to date?

Mark Blunda: Her up to date licenses were given to the original OPRA requestor.

Catherine Soto: Are we keeping her or getting rid of her?

Council President Pabon: She is doing her tax collector job properly.

Catherine Soto: She will be found guilty and the City should get rid of her when that occurs.

Wilfredo Soto, 202 Hidden Village Dr.: Nancy Martin should be investigated. The Hall Ave. shooting video should be shown to the citizens of Perth Amboy. By showing this video, this will bring the community together.

Nicole Nunez, Marlboro, NJ: I just spoke to the OPRA requestor over the phone and she advised me that Nancy's licenses have not been received by her. If you google Nancy Martin, you will find that she is linked with animal abuse.

Mark Blunda: I will check it out and send out the licenses in regular mail.

Virginia Lugo, 316 State St.: I've submitted many OPRA requests and I get bogus information. The departments that supply the info should review it before it is given to us.

Mark Blunda explained the OPRA law to the public, and advised the public that questions are not OPRA. OPRA is only for records and/or documents.

Council Member Petrick to Jillian Barrick, BA: Please follow up and send a letter regarding the support of a train museum in the City.

Council Member Irizarry: Is the fence that the DOT put on the bridge the final fence? This fence attached with zip ties won't stop anyone from jumping.
