### PUBLIC PORTION (5 MINUTES MAXIMUM PER SPEAKER)

Stan Sierakowski, 679 Charles St.: There has been a decline in crimes by 12% according to the "Perth Amboy United" ticket. Does this include murders and drive-by shootings? Are we living in a safer city?

Linda Ferreira, 394 Bruck Ave.: We need to know about the crimes in the City. Crimes are being hidden from us. The Amboy Guardian should report this. The Amboy Guardian is bias. People are complaining about missing street signs. The quality of life is horrible in the City. All of the Council should step down. There's an autism sign that's needed in my neighborhood for an autistic child.

Jose Ortega, 553 Carson Ave.: I live on the corner of Carson Ave. There is 2 hour parking and I have been ticketed.

Council Member Petrick: We have the traffic dept. looking into it. We will resolve your issue.

David Caba, 139 Lewis St.: I submitted an OPRA request regarding the Hall Ave. shooting in December 2013. Is the case still under investigation?

Mark Blunda, Esq.: It is still under review.

David Caba: I am entitled to the info under state statute. I believe it is not under investigation. Nothing regarding crimes in Perth Amboy gets reported by the Home News Tribune.

Alan Silber, 244 Rector St.: I reported the Z-Bar shooting on New Brunswick Ave. to the Home News Tribune. They refused to put it in their newspaper. At Monday's meeting I complained about a religious group that recently used a park and cooked at the park. Ms. Barrick said you are not allowed to cook in a park. Are you allowed to cook in parks? Bathrooms are not open on Monday's and Tuesday's at the park due to budgetary constraints, but it was open for this event. Did they put in a permit for the use of the park? I think it was an illegal use of the park.

Council President Pabon: We will look into it.

Alan Silber: The house next door to me finally had their grass cut. I thank Angel Maldonado, one of our inspectors, for the work he does for the City. I disagree that the Hall Ave. shooting is still under review. The Police officer who was involved in the shooting is back to work. Why is it still under review?

Jillian Barrick: Any park permit request goes through Ken Ortiz at the Dept. of Recreation. Cooking may be allowed in a park, upon request, and permission by the fire inspector.

Ken Balut, 359 Bruck Ave.: Why do we have 3 police officers here at this meeting tonight? Many people are not reporting crimes. We need to let the public know what is going on. The public helps the police. How do you OPRA a verbal command? OPRA's are not meant to give people a hard time.

Angel Leon, 618 Penn St.: Has there been any response to the bridge situation by the State?

Council President Pabon: The Mayor has met with the Commissioner of DOT and there is a process that needs to be followed. They are looking into this and they are discussing permanent options.

Council Member Gonzalez: The meetings regarding the bridge will be held here at the bridge.

Barry Rosengarten, 170 Water St.: The Bill of Rights was signed here first, in Perth Amboy. This year is the 225<sup>th</sup> Anniversary of the signing of the Bill of Rights. We will have the original document on display at the Council Chambers, City Hall, on November 11, 2014. I will ask everyone to partake in the activities that we have on that date. I invite everyone to the festivities.

Reinaldo Aviles, 16 Harbor Terr.: I like that all the directors are at the Council meetings to answer questions. We need better signage at the City Hall circle. I sat in Municipal Court recently and a certain judge is running a debtors prison. He discourages payment plans and sends people to prison if you don't have the money. This should be looked into. The Court is not a revenue stream.

Gregory Pabon, 437 Ashley St.: I like seeing the department directors at Council Meetings. I walk in the Budapest area every evening. I have not heard of crimes in my area.

Jillian Barrick: There is no overtime being paid to department heads for attendance at meetings.

Council President Pabon to Ben Ruiz, Police Chief: Can we look into replacing some street signs that need it.

Chief Ben Ruiz: Signs are being made. We will be putting them up, but we will be looking to weld them. Autism and handicapped signs go up immediately.

Council President Pabon: How is crime reported to the press?

Chief Ben Ruiz: We make it available to the press, and they pick and choose what they want to print. We send Nixle reports to the public and to the press. We send out reports on a daily basis. Nixle also reports on Facebook.
