PUBLIC PORTION (5 MINUTES MAXIMUM PER SPEAKER)

Stan Sierakowski, 679 Charles St.: Perth Amboy has declined under Mayor Diaz. There is no integrity with her or her department heads. The streets are not safe. Mayor Diaz does not attend many council meetings and when she is here, she never answers any questions. Don't forget to vote on November 4th. The Mayor claims the Bd. of Ed. is not doing their job with regard to the new high school. Yet she never goes to any Bd. of Ed. meetings. The Board President claims the Mayor has not reached out to her to discuss the new high school.

Leslie Dominguez-Rodriguez, 758 Convery Blvd.: I am asking again that the City Council place a resolution on the agenda making Perth Amboy a partisan community. One of the election tickets (the one using the State Street Office) is using the democratic designation, even though there are no democratic ties. That is misrepresentation. We need to fight for a municipal partisan election. The use of the term "democratic" is against the Hatch Act. Mr. Pabon works for the federal government. He should be careful.

David Caba, 139 Lewis St.: Recently my relative who owns a business in town was pistol whipped and robbed. Did anyone from the Council go visit him? Why is Senator Joe Vitale so involved with our local politics? Is he trying to buy the election? There are numerous acts of crime and the residents are being misinformed. The people of Perth Amboy should decide who should be put in office, not someone from out of town telling voters how to vote.

Iris Rodriguez, 335 Fayette St.: I am disheartened by what is occurring in this city. Our quality of life is going down. We need to take our streets back. You need to look at the parking situation due to the two bars near my home. We have many out of state plates living in my area. Perth Amboy residents cannot use the Woodbridge library. Senator Vitale should look into that.

Alan Silber, 244 Rector St.: Joe Vitale donated monies to three people running for council in this upcoming election. Watch out for him. He just wants to be a big boss in Middlesex County. I still did not get a response with regard to an OPRA request for the permit for the use of Bayview Park.

COUNCIL COMMENTS

Council Member Petrick: Being non-partisan makes us even more of a democratic community. This allows as many people as want to run for public office.

Council President Pabon: The headquarters says "Perth Amboy Democrats" not "Democratic Organization".

Council Member Nanton: In the past, we were asked to change to a partisan election system. We asked how the change to "partisan" would benefit the residents of Perth Amboy. The info supplied was a copy of the ballot and a copy of the dismal turnout reflected in the primary election results. If the turnout will be lower in partisan elections such as the primary, how will that benefit us here? I am not in favor of turning it partisan. It will eliminate a lot of talent from running for political office. The Green Team received "Bronze Sustainable Jersey Certification". It is a prestigious recognition. The 2014 Beautification Awards have been awarded (Listed the Winners in the commercial/business category).
