NOTICE OF MEETING

Acting Presiding Officer of the Council, Elaine M. The sole purpose of this meeting is to select a Council President and to consider Resolutions relative to the reorganization of the City Council.

NOMINATION OF COUNCIL PRESIDENT

Elaine M. Jasko, City Clerk: May I have a nomination for consideration for the position of Council President.

Motion was made by Council Member Petrick, seconded by Council Member Nanton to nominate Council Member Kenneth Gonzalez for the position of Council President.

Council Member Kenneth Gonzalez: While I am honored with the nomination and support by my fellow members of the Council, I am going to decline at this time. I do not do this lightly. In all candor, I had seriously considered accepting the nomination. However, there are a small vocal number of citizens who have been attempting to malign my character and the character of my family. It's important to me that the work of this City Council be first and foremost in the minds of the public and that Perth Amboy continue to move its agenda forward.
